Section 9: **Treatment planning, Research, and Evaluation** – average of 3 items with score range 0-4. Section 10: **Counseling Dispositions** – average of 10 items with score range 0-5.

# Section E. Alumni Data

The Career Development Center at UNH retains alumni data related to employment. Their data shows that 100% of CMHC graduates since 2021 are employed either part time or full time. Many have gone on to pursue additional graduate study.

In addition, the CMHC program Faculty developed a survey for alumni that is sent out annually to understand trends among successful graduates. Results include 18 alumni responses from classes of 2020 (n=1), 2022 (n=4), and 2023 (n=13). Survey respondents noted general satisfaction with CMHC program preparedness measures across domains (i.e., diversity, professional development and identity, counseling skills, etc.). One area for growth in program delivery, as identified by Alumni, is providing greater preparedness related to policy and leadership as well as professional identity.

Regarding employment, 10% of participants report being in their current position for 3+ years, while 40% report 1-2 years and 50% report being in their current position for less than one year. Further, 80% report finding a job position in the mental health field, while others report issues with career timing (5%) and going back to school (5%). Alumni reported a range in salary from \$30k to over \$70k. Most are provisionally or fully licensed.

# Section F. Annual Student Reviews

At the end of each spring semester, all students in the CMHC program engage in an annual review process where students are expected to complete a self-review survey. Faculty also meet to discuss students' performance, individually, and feedback is provided directly to each student. Each student in the program is sorted in to one of 3 categories: good - meets expectations, fair – improvements suggested, poor – improvements required. Students coded as fair and poor receive a meeting with identified faculty and/or a formal remediation plan for target improvement areas. Out of 111 students enrolled in the CMHC program during AY 23-24, 49 (44%) students completed the self-evaluation survey in Qualtrics. Overall, 104 (94%) students were coded as "good – meets expectations," 6 (5%) were "fair – improvements suggested," and 1 (.01%) was deemed "poor – improvements

required," wherein a remediation plan was developed and carried out by identified faculty.

# Section H. Program Modifications

During the 2023-2024 academic year the CMHC program developed and/or implemented the following modifications:

- Applied for CACREP (Council for Accreditation of Counseling and Related Educational Programs) accreditation.
- Began providing Licensure and Credentialing lecture for all program students in Counseling Internship II (COUN 6692) each semester.
- 3rd annual Residency week for online students during the first week of June (3-7) in Summer 2024.
- 1<sup>st</sup> annual advisory board meeting with key site supervisors and faculty to discuss program strengths and areas for improvement held on June 6, 2024.
- 1<sup>st</sup> annual program mixer with current students from the on-ground and online programs, alumni, site supervisors, and faculty held on June 6, 2024.
- Hosted a CACREP in-person Site Visit in July, 2024.
